**RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK, AND
INDEMNITY AGREEMENT**

In exchange for participation in the activities of swimming, sunbathing, and playing organized by Dallas Swim Club Royal (dba Club Royal Pool), of 3433 Townsend Drive, Dallas, Texas 75229, I agree for myself and (if applicable) the members of my family, to the following:

1. **AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, **including those stated in the 2023 Membership Agreement**, and further agree to follow any oral instructions or directions given by Dallas Swim Club Royal (dba Club Royal Pool), or the employees, representatives or agents of Dallas Swim Club Royal (dba Club Royal Pool.)
2. **ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activities, and I assume full responsibility for personal injury to myself and (if applicable) my family members, and I further release and discharge Dallas Swim Club Royal (dba Club Royal Pool) for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Dallas Swim Club Royal (dba Club Royal Pool), whether caused by the fault of myself, my family, Dallas Swim Club Royal (dba Club Royal Pool) or other third parties.

7. **ENFORCEABILITY.** The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provisions shall be deemed not to be a part of this Agreement.
